What is Assymmetric Information?

Asymmetric Information is concerned with studying various types of decisions regarding transactions where one party is well informed compared to another.

For example: In case of sale of used car, the individual or dealer selling the car typically knows more about the vehicle than the party purchasing the vehicle.

Economic Impact of Assymmetric Information?

Asymmetric Information can impact the overall economy in a very disastrous manner where one party can cause damage to other parties because of availability or access to better or more important information.

For example, one party in a financial transaction may not disclose true and complete facts about the transactions which may result in future loss for the party in the transaction, which may result into increase in the cost to other parties which in turn can increase the cost of products in overall economy.

How Government can take benefit of Assymmetric Information?

Due to its nature, Government can gather various amount of data through Asymmetric Information which can be used to prepare policies, laws, and regulations. Such information is not revealed until the law becomes operational.

Asymmetric information allows government to make policy decisions which is in the good faith of the public without disclosing the information to anyone. This avoids or lessens the challenges and disregards (which would have been encountered, had such information is known to public) enabling government to make regulations without facing any difficulties.

Example: Government can collect the data of people who have the health insurance in the country and then analyse the percentage of people taking the insurance policies vis-à-vis money spent by everyone over the medical treatments.

This is considered an asymmetric information and government can brought in a law where it mandates the health insurance for everyone in the country which is in the best interest of the people.

Similarly, asymmetric information can be used by government in gathering the information related to how many children within a particular age group are having the access to schools and other necessary things and find the right set of people who can avail the benefits of policies developed by the government to help them.

Once these policies are regularized, such information can be made public to know the rationale behind such regulations.



MARKETS WITH ASYMMETRIC INFORMATION

Quality of an Assymmetric Information?

An asymmetric information must be of good quality and value, otherwise it can cause harm and destroy the whole intent of the policymakers.

For example, in a case where government want to promote the CSR initiative, it provides subsidy to the farmers. But, to make the initiative successful, it is necessary to identify the right set of people to whom such incentive should be given. If the subsidy is given to the wrong set of people or who are not more socially responsible, it may lead to a moral hazard situation where the beneficiaries will misuse the incentive.

So, it is crucial to improve the quality of information which can form an efficient incentive compatibility between the enterprise and public. Moreover, the coverage of analysts should also be efficient to improve the information quality and target the right set of beneficiaries.

Assymmetric Information favours Government?

The answer to this question is Yes. In a situation where government receives money due to asymmetric information and there are no laws or regulations to find your whereabouts, government can use that money for its benefits as in money market funds.

For example: State of Texas buys land from citizen who dies, and state send check, but it returned to the state. State doesn't notify citizen estate (as there is no regulation for that) for check to be delivered to so state sets on asymmetric information in state bank collecting interest on uncashed check.

As another example, when government make the healthcare budget, it keeps the largest share for old people matching with their insurance contributions while it keeps lower budget for the people who provide strong information for their health. This is a classic example of two-sided asymmetric information where neither the patients nor the government possess perfect information about the other party's type, health conditions and effort level.

In this scenario, government tries to build a gap between healthcare budget and patient contributions to utilize some part of healthcare budget to other means.
